## INVITATION TO e-BID

1. Naya Pakistan Housing and Development Authority (NAPHDA), Islamabad, invites electronic bids on an **open framework agreement** for the fiscal year **2024-25** by following the **Single Stage Two Envelope** procedure from eligible and reputable firms, companies or authorized suppliers that are registered with relevant tax departments of Income Tax (IT) and General Sales Tax (GST) and are on the **Active Taxpayer List** with the Federal Board of Revenue (FBR), having their own outlets or offices in the **Islamabad/Rawalpindi region** for the supply of brand new imported tyres of different sizes for official vehicles.
2. All bidders should be registered with PPRA on E-PADS. E-bids containing detailed terms and conditions, specifications and requirements, etc. are available for the registered bidders on E-PADS at ([www.eprocure.gov.pk](http://www.eprocure.gov.pk)) and can be downloaded free of charge, from **16<sup>th</sup> December, 2024 to 1<sup>st</sup> January, 2025**.
3. The eBid must include **5%** earnest money (refundable) in the form of CDR/ Bank draft/Pay order in favor of **DDO NAPHDA Islamabad**.
4. Electronic bids must be uploaded using e-PADS from **16<sup>th</sup> December, 2024 to 1<sup>st</sup> January, 2025 at 1100 am**, where manual bids will not be accepted. E-Bid Opening Committee will be held for opening of e-Tender / e-Bids at **11:30 am on 1<sup>st</sup> January, 2025** in the presence of quoted firm representatives.
5. Suppliers are requested to provide final prices and NAPHDA reserves the right to increase or decrease **15%** of their original quantity. The validity of offers should be up to **30<sup>th</sup> June 2025**.
6. The tender opening time or date will be automatically rescheduled to the next working day in case of closed, forced holidays, or other circumstances.
7. Contractors must submit technical and financial bids with relevant documents demonstrating qualifications, experience in supplying tyres to government or corporate entities, and compliance with laws and regulations. Goods must be delivered as per the requirements of the NAPHDA after issuance of the purchase order or notification of award.
8. The Naya Pakistan Housing & Development Authority reserves the right to accept or reject all bids, and to cancel the process of competition at any time prior to the award of the Contract, without thereby incurring any liability to the affected Supplier(s), also not required to justify the reasons.
