Standard Operating Procedure (SOP) For Issuance of Certificate by NESPAK to Builders & Developers as per Presidential Ordinance & Finance Act 2020-2021

This refers to the subject of issuance of certificate by NESPAK to builders and developers as per Presidential Ordinance and Finance Act 2020-2021. The requirements specified under Rule 4 of the Eleventh Schedule to the Amendments in the Income Tax Ordinance 2001 included in the Tax Laws (Amendment) Ordinance, 2020, are reproduced as below:

- **"4. Certification**: Every builder or developer shall be required to obtain and provide to the Board in the prescribed manner a certificate from approving authority or map approving authority or NESPAK, as the case may be, to the following effect, namely:
 - a) "total land area" in square yards;
 - b) "covered area" in square feet;
 - c) "saleable area" in square feet; and
 - d) Type (commercial, residential or industrial) of saleable area or the total land area as the case may be."

The following SOP is to be followed for issuance of this certificate by NESPAK:

- 1. The certificate will be issued to:
 - i) the builders and developers who are members of Association of Builders and Developers (ABAD); their applications will have to be endorsed by ABAD.
 - ii) the builders and developers who are not members of ABAD; their applications will have to be endorsed by NAPHDA.
- 2. The applicants will file the certification request (under their letter head duly endorsed by ABAD or NAPHDA as noted above) to designated focal officials of NESPAK at its offices in Lahore, Karachi and Islamabad, along with one original and one copy of either of the following plans (as applicable) that are duly approved by the local map approving Authority under the name of the applicant:
 - i) Master Plan (For housing schemes exclusive of buildings planned therein)
 - ii) Building Plan (For individual buildings)
- 3. NESPAK will issue the certificate as per enclosed format on its letter head on the basis of only in-office review of above plans.
- 4. NESPAK will bear no liability:
 - i) for ascertaining the ownership title of project land in the name of applicant,
 - ii) for ascertaining the authenticity of approved plans submitted by the applicant,
 - iii) for ascertaining eligibility of applicant as per Ordinance requirements.
 - All liability on the above accounts will rest with the applicant.
- 5. NESPAK will retain the copy of approved plans for its reference while the original of approved plans will be returned to the applicant.
- 6. NESPAK will charge advance fee of Rs. 200,000/- for issuance of the certificate, payable in the form of cross cheque in the name of "NESPAK Pvt. Ltd.".
- 7. NESPAK will issue the certificate to the applicant within three days after receipt of advance fee and the required plans as mentioned above, provided the plans contain all the requisite data.
